1. Resolution 181108A

**Motion** made by Vite, seconded by Payton to approve Resolution 181108A – "Resolution to Approve Distribution of the Draft Bertrand Township Master Plan Update and Assert the Township Board's Right to Approve the Plan".

**Discussion:** PC Chairman Mark Wagner gave a brief presentation to the board re: the status of the Master Plan Draft. The Resolution is required by the state to distribute to neighboring communities and relevant agencies.

## 2. Marihuana Establishment Ordinance 2018-1108A

**Motion** made by Vite, seconded by Payton to adopt Ordinance 2018-1108A – "An Ordinance to Completely Prohibit Marihuana Establishments in Bertrand Township".

**Discussion:** Supervisor Hicks shared a communication from our township attorney with her advice for the board to consider that the state currently has weak and untested systems in place re: security and safety of commercial recreational marihuana establishments. By default, the township is "opted in", but Section 6.1 of the Michigan Regulation and Taxation of Marihuana Act of 2018 ("MRTMA") that just passed on November 8 allows municipalities to completely prohibit them through the passage of an ordinance.

# 3. Review of Landfill Resolution & Study

**Discussion:** City of Niles has passed a Resolution and is urging each of the member municipalities of the SEBC Landfill to do the same to determine questions for a feasibility study. They were pressing for our board to pass this resolution at this meeting. Treasurer Kuhn and Trustee Zelmer, being our representatives on the landfill board, expressed their reservations in hastily doing anything without very diligent and careful deliberation. They have requested a special meeting to discuss the issues further and give time to consider the ramifications.

Supervisor Hicks called a Special Meeting for Thursday, November 29 at 6:30 p.m. at the township hall.

WHEREAS, the Bertrand Township Planning Commission has prepared the draft 2018 Bertrand Township Master Plan, being an update to the version last revised on April 4, 2013;

WHEREAS, on October 18, 2018, the Planning Commission recommended distribution of the draft Master Plan update to neighboring communities and relevant agencies, as required by Section 41 of the Michigan Planning Enabling Act, as amended.

### IT IS, THEREFORE, RESOLVED AS FOLLOWS:

- 1. The Board asserts its right to approve or reject master plan revisions and updates.
- 2. The Board hereby approves the distribution of the draft 2018 Bertrand Township Master Plan prepared by the Planning Commission and submitted at this meeting of the Township Board to neighboring communities and relevant agencies, as required by Section 41 of the Michigan Planning Enabling Act.
- 3. The Township Clerk shall distribute of copies of the Master Plan to the neighboring communities and relevant agencies entitled by law to receive copies of the draft plan; request comments within 42 days of receipt; and provide notification of the official Planning Commission public hearing date.
